5. That the qualified staff within the age limits prescribed by the Government for Government employees shall be appointed as per the staff pattern. The Teaching staff shall qualify the AP TET.
6. That the results of institution shall be satisfactory every year.
7. That the records / accounts, annual administrative report along with the audited accounts should be submitted to the D.E.O. every year by 30<sup>th</sup> September at latest.
8. That the list of governing body shall be furnished to the D.E.O. every year.
9. That the pay structure/fee structure fixed by the governing body shall be submitted to the D.E.O. every year.
10. That all the conditions prescribed in the G.O.s and other orders which are not specified in this orders shall be complied with.
11. That the school shall not be closed without giving notice both to the parents/D.E.O. and competent authority at least 6 months before.
12. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. That the society shall submit proposal for renewal of recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the present recognition.
14. The management informed that no thatched roof accommodation is allowed to run the school.
15. Proper and adequate sanitation facility shall be provided for students especially for girl students.
16. The school shall follow the traffic and safety measures shall be taken for children within the school campus and also near the school premises.
17. The school shall follow the traffic and safety guidelines indicated by the police and fire services, Departments.
18. The parent teachers associations meeting shall be conducted to sensitize the parents on the safety of the children.
19. The school shall have first aid kit and the teachers shall be trained in first aid.
20. The Correspondent of the concerned school is hereby informed & instructed to **file an affidavit every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.**
21. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year.
22. That the management shall take every responsibility for the timely, safe and comfortable mobility of the School Children from the residences to School and vice versa.
23. That the School Van should be ensured road worthy for the transportation mobility of school children.
24. That the school van should be freed from all taxes due and should be maintained with regular checks by authorized mechanics periodically / as and when required without causing any sort of dislocation for the school children opting the van facility.
25. That the management shall engage skilled experienced and authorized drivers having good health and good vision for the school vans.
26. That the management shall insure the vehicle and safety grills be provided to all the windows of the vehicles without fail.
27. That management shall ensure the accountants of this school audited by an authorized chartered accountant every year and submit audit report to the undersigned.
28. The management shall have to follow the rules 15,17 (C) & 18 of Go.Ms.No.1, Edn., Dt.01.01.1994 and other guidelines issued from time to time with regard to fee structure in private Schools.
29. That the management shall ensure all the children are brought/upload the child info immediately.
30. The management should maintain & provide all firefighting equipment for fire safety as per the AP Fire Safety Act 1994 & Rules 2006 and shall submit renewal of FIRE NOC every year to the undersigned.
31. The Management shall submit periodical certificates along with Affidavit every year without any deviation.
32. That the orders now issued are subject to condition that the management shall submit the registered lease deed for play area /land as play area ( as per the undertaking given by them),before school reopens, otherwise orders shall be reviewed without any prior notice.

Lease Deed for the remaining 1300 Sq. Mts in favour of the Educational Society concerned.

Yrds (2428.114 Sq. - 11 That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before
- 12 That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13 That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
- 14 That the society shall provide fire safety measures in the school as per the No Objection Certificate.
- 15 The management is informed that no thatched roof accommodation is allowed to run the School.
- 16 The management shall provide proper adequate Toilets / sanitation facility to the students & Staff.
- 17 Proper and adequate safety measures shall be taken for the students within the school campus and also near the school premises.
- 18 The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
- 19 The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the students.
